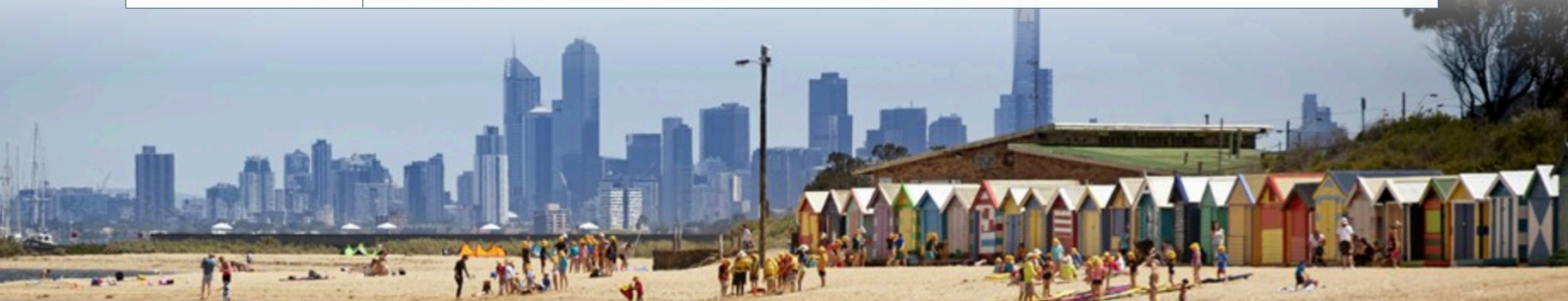

Paediatrics: rationalising psychotropic medication in school aged children

– *Dr Megan Yap*

Developmental and behavioural problems are common in children and adolescents, and pharmacists are well placed to assist. This session discusses the prevalence and treatments of these conditions and providing advice to parents.

Soft tissue injuries: from acute to subacute

– *Anjelo Ratnachandra*

Pharmacists are well placed to provide early management advice and referral for patients with acute soft tissue injuries. This session will provide the skills to examine and assess the patient, as well as discussing healing and rehabilitation post injury.

New drugs update: what the future holds

– *Angus Thompson*

What new medicines or indications are on the horizon? This session will provide pharmacists with insight into new medicines, new indications for known medicines, safety updates and upcoming medicines.
