



# Summary of legal authority for pharmacist administration of medicines

## **PURPOSE:**

This table summarises the current legal authority for Australia's pharmacists to administer medicines, which differs according to jurisdictional legislation. This summary should be read in conjunction with PSA's [\*Guidelines for pharmacists administering medicines by injection\*](#).

Information in this table relates to the general authority for the administration of medicines and does not provide an exhaustive summary of pharmacist authority to administer specific medicines.

This summary has been sourced from the latest available information and is current at the date of publication. At all times, pharmacists must meet the specific legislative requirements in their state or territory and are expected to exercise professional judgment in the context of adapting this guidance to their presenting circumstances.

**Note:** If a medicine is to be administered by injection, pharmacists should have completed an accredited course about administering medicines by injection and any other specialised training to administer a specific medicine by injection if required.
