Since the introduction of specialised remuneration services into Australian Pharmacy Practice with medication reviews in aged care facilities in 1997 pharmacists have played an increasingly important role in aged care. This award aims to recognise those pharmacists who have adopted and implemented outstanding services to residential care facilities and their residents.

All credentialed pharmacists are encouraged to reflect on the work of their friends and colleagues working as credentialed pharmacists in the aged care space and to consider nominating them for this prestigious award.
