# PSA Awards 2025

## *Terms and conditions*

### Entry into a PSA Award and acceptance of the prize is deemed acceptance of these conditions of entry.

1. Entry is only open to PSA Members, and employees (and their immediate families) of the Promoter are ineligible to enter.
2. Winners' names will be published on [www.psa.org.au](http://www.psa.org.au), and the PSA Social media channels. Each entrant consents, if the entrant becomes a Winner, to the Promoter using the entrant's name, in any media for an unlimited period of time without remuneration for the purpose of promoting this promotion (including any outcome), the Promoter and/or products/services supplied by the Promoter.
3. Prizes are to be used for pharmacy educational purposes, and will be administered by the PSA.
4. Travel (when included in the prize) will be via the most direct route, economy class.
5. Unless otherwise stipulated, no prize, or any unused portion of a prize, is transferable, exchangeable or redeemable for cash. Prize money must be used within 24 months.

If for any reason whatsoever beyond the reasonable control of the Promoter, the competition is not capable of being conducted as reasonably anticipated, the Promoter reserves the right, in its sole discretion, unless to do so would be prohibited by law, to (a) disqualify any entrant; and/or (b) to cancel, suspend, modify, terminate or cancel the award.
